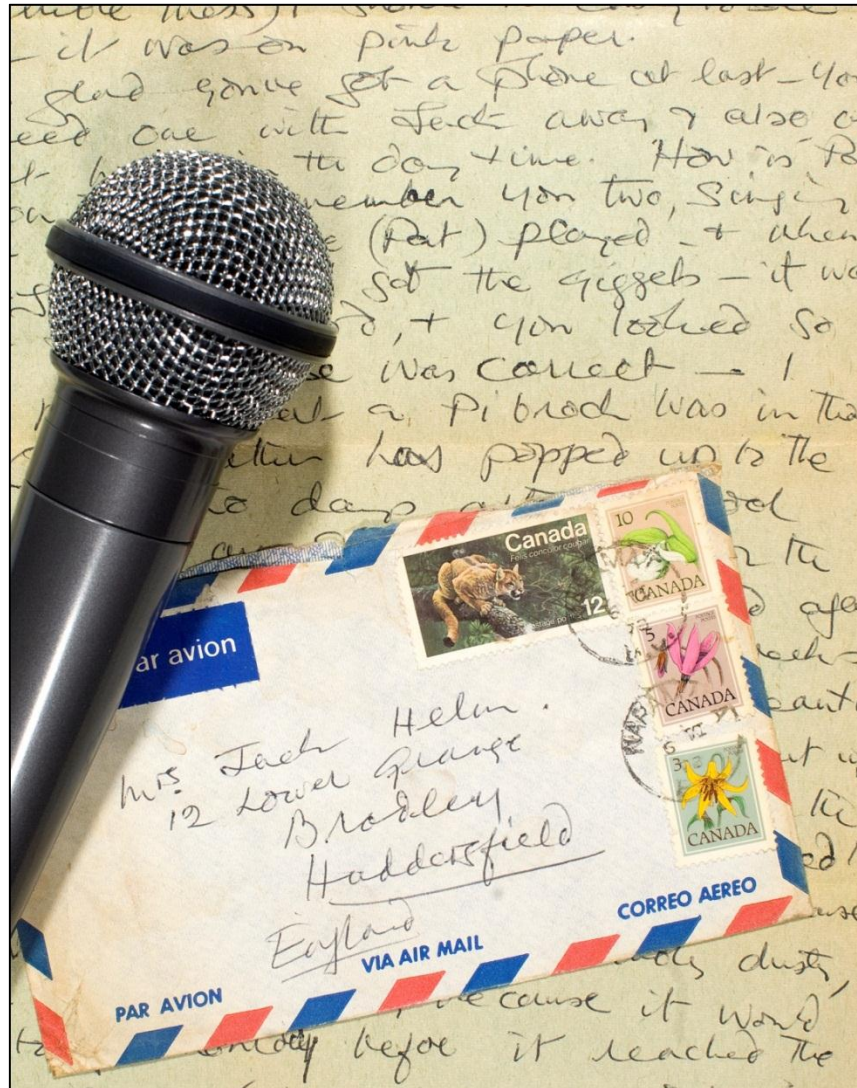

## MISSION STATEMENT

Life history and life writing research uses life story - whether in the form of oral history, personal narrative, autobiography or biography - as a primary source for the study of history and culture.

Research involves grappling with theories of memory, relationship and self-representation, and with debates about literacy and orality. Many disciplines contribute to the field, including history, sociology, anthropology, literary philosophy, media and cultural studies and psychology. Life history and life writing researchers present their work in many forms. As well as academic publications, we contribute to radio and television documentaries, auto/biographical drama, reminiscence work, digital and video presentations and exhibitions. Life history and life writing research is, of necessity, concerned with ethics and power relationships, and with the potential for advocacy and empowerment and has evolved complex methodologies which use as well as analyse the life narrative in all its forms.

Our aims are therefore to promote the study of life history and life writing; to promote the use of life narrative-based methodologies; to encourage practice-based research where appropriate; to foster ethical relationships and empowerment through informed uses of life story work.

## DIRECTOR'S REPORT

### STRATEGIC HIGHLIGHTS

This year we have relaunched from the School of Media, Film and Music after many years in the Centre for Continuing Education. This has allowed new colleagues and research synergies, including in sound studies, public culture and documentary practice. We have also strengthened ties with Gender Studies, Art History and History, cooperating on research events and developing a postgraduate network with school representatives. The longstanding partnership with the Mass Observation Archive and Special Collections has also been invigorated, with a new short course and masterclass series. Our Visiting Fellow this year, Dr Jenna Bailey of the University of Lethbridge, has brought cooperation with Canadian scholars, and her work in the area of public and literary life history affirmed our ongoing community engagement.

### FINANCIAL HIGHLIGHTS

The budget for the CLHLWR remains healthy. We brought forward a balance, accrued through research funds generated by the Director, and profit made from conferences. In line with other Research Centres funded by MFM, we also received annual core funding towards events and running costs, for which we are very grateful. Careful management and separation of rollover from annually given funds means that we look forward to continuing a full programme of activities in 2014-15, particularly in relation to strategic partnerships that will generate further research.

### OPERATING HIGHLIGHTS

Stable funds and support from MFM has enabled hire of two part time administrative assistants this year, Dr Alexandra Loske, an art historian with specialisms in biography and life history documents, and Angela Campos, an oral historian with specialisms in the history of war. Their work has been invaluable to the flourishing of the CLHLWR this year, including in developing a social media presence.

### LOOKING AHEAD

In addition to our regular programme of seminars, short courses and conferences, next year will see the renewed development of research bids, including developing the oral history of the BBC, to cooperate further with Chinese scholars who partnered with us in 2012-13, and to strengthen our research on human rights and life narrative. Our annual conference will be on art historical uses of life narrative. We welcome all who would like to get involved in the challenge and fun of life story-based art, method and analysis.

Life history methods across disciplines offer special challenges but they also offer uniquely rich results. This conference will focus in particular on the tension between analysing the individual's unique experience and understanding the social or collective contexts which define it. It will also more broadly address the complexity and variety of its methods as it is used across disciplines, from qualitative social sciences to literary autobiographical studies, to oral history, the documentary arts and narrative psychology. It will consider the experience of the researcher as we find ourselves steered in unique investigative directions, thus shaping the way knowledge develops in particular ways. It will acknowledge how researchers working in this field are more likely to encounter and tackle challenging, underexplored or unexpected themes not always present in mainstream narratives or 'traditional' sources.

We invite postgraduate participants to present at this conference their contributions on why it was pivotal to prioritise the life history methodology in answering initial research questions and how this approach subsequently shaped and impacted their research and findings.

Lunch provided and workshop-style presentations encouraged.
