Oil-Spoils-Soil - 3 November we heard Maddy Ryle (Democracy Centre, Bolivia and UK) and Stephanie Guthridge (independent scholar-activist, Ecuador and UK) talk about environmental justice and fossil fuel extraction in Bolivarian Latin America. A podcast link:

Contested Realities- Adivasis in the Anthropocene, 20 November, focused on Central and Northeastern India, with examples of Resource Curse from Jharkhand, Nagaland, sites of iron ore mining causing Adivasi to be trapped in the crossfire between Maoists and state repression, large scale land alienation and collapse of social structure. A booklaunch of Mission Saranda by Gladson Dungdung followed in Sussex and Brunei Gallery in SOAS, London. Speakers included: Gladson Dungdung (Jharkhand Activist), Brian Morris (Goldsmiths), Felix Padel (JNU), Robert Wallis (photographer) and Geoffery Whitefield (Chaplain Sussex).

Keep Oil in the Ground – The Yasuni ITT Park Initiative in Amazonian Ecuador, 6 December 2015, Paris. Prof. Carlos Larrea was behind the Ecuadorian government not to extract oil in the Yasuni Park in Amazonian Ecuador between 2007-2013, and presented the the Yasuni ITT Initiative at the Activists and Academia Forum – CWEH on a number of occasion in the past 2 years. Gloria Ushino, Yasuni indigenous activist - joined our speakers together with Rights of Nature advocate Natalie Greene, and young Yasunidos activists building an international movement working to reinstate the Yasuni in Ecuador. The network supported another meeting in Paris: We Can Stop Destructive Mining – Victories in Niyamgiri, India and Zambia, called by Foil Vedanta.
