In Februay this year we got some positive network updates:

- At the end of February 2018 we got reports from Saranda rights activist Gladson Dung Dung about activity of local movement against the Jharkhand Government decision to reject the forest rights claims, based on the Forest Rights Act 2006. Several villages are effected in the region of two coal blocks - Rajbar

and Banhardi - following the allocation of coal blocks in Latehar by the Jharkhand Government.

- The Tesoro Escondido Spider Monkey Reserve and new cacao producing eco community – Choco, in support of local communities to improve their living and help with conservation work in Ecuador. The focus is on critically endangered brown-headed spider monkey Ateles fusciceps fusciceps, which is one of the top 25 most endangered primates globally. - A report about a third High Court ruling in London in favour of the Zambian government and people, and against Konkola Copper Mines (KCM, subsidiary of mining company Vedanta Ltd.) since 2014: The High Court ordered KCM on 2 January 2018 to pay \$139 million, including costs, to the Zambian government for a copper and cobalt price participation agreement dating back to 2004.
