# **Funding news**

Professor Chris Marsden (PI) and Dr Andres Guadamuz (CI) in Sussex Law School have won funding from European Commission Directorate General JUSTICE for a two-year study into how to make European (and British) law more accessible to citizens. Access to law is a basic requirement for the rule of law that online tools – such as the smartphone app used in this project – can finally make into a reality. Sussex will lead the initial comparative analysis of law, society and institutional developments towards the open access model, past developments and prognosis for the future. The total project value is €684,300

The annual politics UG trip to Berlin took place from 17-22 March. 18 students plus Dan Hough (Politics), Kim Brayson (Law) and Kai Oppermann (Politics) spent six days in the German capital, speaking to a range of politicians and political activists. The group also managed to fit in a day in Leipzig, as well as visits to the Stasi memorial in East Berlin and the Holocaust Memorial in central Berlin. ### LPS in the news

Sussex Law Professor Craig Barker has defended the international law of diplomatic immunity as part of an ITV documentary entitled 'Exposed: Inside the Diplomatic Bag' shown in March. Professor Barker was invited to contribute to the programme as the UK's leading expert on the subject of diplomatic law.

He was asked in the programme to explain the importance of diplomatic immunity as a tool of international diplomacy. Professor Barker agreed that it was possible for diplomats to abuse their privileges and immunities but highlighted the rarity of such events. He also noted the importance of diplomatic immunity as a tool for the protection of individuals serving the United Kingdom abroad.

The programme was presented by investigative reporter Mark Williams-Thomas and featured an undercover investigation into an accountant working within the Nigerian High Commission in London who had claimed that he was able to smuggle stolen art out of the United Kingdom using his diplomatic connections. The programme included a wide-ranging review of the extent and purpose of diplomatic immunity. Dr James Hampshire (senior lecturer in Politics), was a speaker at a panel discussion on 'Immigration: Asset or Liability' organised by the Democracy Forum at the House of Commons.

The panel, held on 20th May, was chaired by Sir Peter Luff MP and the panellists were Yasmin Alibhai-Brown (The Independent), Alex Betts (Oxford), Michael Keith (Oxford), Alp Mehmet (Migration Watch), and Dr James Hampshire (University of Sussex).

Dr Hampshire gave a talk on European migration and Britain's relations with the EU and was also interviewed by NDTV, an Indian news channel, about Indian student migration.

Sussex Law student Beenish Saeed has won the Outstanding Diplomacy award at the Harvard World Model United Nations 2014.

Beenish, a second-year LLB student and member of the Sussex Model United Nations Society, won the award thanks to her debate on how to resolve the pressing problem of income inequality in Latin America and the Caribbean.

Beenish said: "We decided to enter and participate as delegates in order to take the Sussex Model United Nations Society one step ahead of its predecessors.

"The topics for debate - from resolving Income Inequality in Latin America and the Caribbean and Drone Usage without a War Declaration to addressing Mental Illness and Ethnic Conflict - were also of great interest to all those who participated.

"The conference also encompassed a wide variety of social events that helped us in establishing new friendships and making memories that will last a lifetime."
