(b) Zoom talk

SJH asked on what basis we choose a talk (collective answer: whatever will fly!). A debate between Dave Goulson and Francis Ratnieks would be a coup, celebrating Sussex's exceptional bipartite expertise in bee science. **SJH** will investigate.

(c) Fishbourne Roman Palace

(d) Other possible tours
