# THE ROLE OF THE EXTERNAL EXAMINER

#### **Purpose**

- Ensure academic standards align with the key principles of transparency, consistency and independence in the UK Quality Code for Higher Education on External Expertise.
- Consistency a standard process for moderation
- Provide externality to the moderation process

# THE ROLE OF THE EXTERNAL EXAMINER

### **Responsibilities:**

### **1. Contribute to Quality Assurance**

- Provide independent feedback on teaching and assessment processes.

#### **2. Moderation of Assessments**

- Review assessments and marking for fairness and consistency.

#### **3. Attend Exam Boards**

- Participate in Progression and Award Boards (PAB) to validate results and classifications.

#### 4. Annual Report

- Submit an annual report with observations and suggestions.

### PURPOSE OF PGT MAIN PAB

- Consider candidates for award who have completed any required resits and submitted the dissertation/project in the summer vacation assessment period.
- The Resit PAB will reconvene in March 2025 to confirm award decisions for candidates who submitted the dissertation/project in the Semester 1 assessment period (first attempt or resit attempt) and/ or have other assessments to retrieve.

## MODULE ASSESSMENT BOARD

- Confirms and maintains standards of assessment and ratifies module marks.
- To recommend action to be taken in the case of question papers where there are errors or assessments about which there are evidenced major concerns.
- To recommend action to be taken in cases where academic judgement concludes that an assessment has been unexpectedly easy or difficult, or where students within a cohort may be markedly advantaged or disadvantaged by their particular choice of modules. The scaling of marks, in line with University guidance, may be considered in such situations.
- To exceptionally recommend proposed outcomes for approval by the Pro Vice-Chancellor (Education and Students) in all cases where external moderation has not been conducted on a module, to ensure that progression and award decisions are not unduly delayed.

## PROGRESSION AND AWARD BOARD

- Recommend awards and exit awards
- Make academic judgements in relation to accepted Exceptional Circumstances claims and to grant further resits as sits or a repeat stage
- Apply discretionary assessment regulations
- Recommend condoned credit
- Determine resit or repeat requirements

### QUORACY

#### **Quoracy of Assessment Boards**

#### Module Assessment Boards (MAB)

- Minimum quoracy is the Chair, Deputy Chair and 2 other examiners.
- External Examiners are not required to attend meetings but should be available for consultation if necessary.

#### **Quoracy Progression and Award Boards (PABs)**

- Where a final award is to be made, the PAB must meet in full. The quorum is the Chair, Deputy Chair and at least one third of the appointed members of the Board.
- At least one External Examiner should be present at each PAB where an award is made

## AWARD REGULATIONS

Regulation 189/193:

A student who is registered for a Masters degree will be considered for the award where they have achieved not less than 180 credits at the prescribed level as set out in the Academic Framework and a capped stage mean of 50% across the stage. The credit requirement may include condoned and compensated credit where this has been given by the PAB.

Distinction: An overall grand mean of 70 – 100% plus 50% of the credit at 70 or above Merit: An overall grand mean of 60 – 69% plus 50% of the credit at 60 or above Pass: An overall grand mean of 50 – 59%

## BORDERLINE ZONE FOR POSTGRADUATE AWARDS

Regulation 194:

- The University operates a borderline zone at all the classification boundaries. A PAB has the discretion to reclassify a postgraduate student where they have achieved either:
  - a grand mean mark of up to 1% below the higher classification boundary and at least 50% of the credit that contributes to classification in the higher class *or*
  - a grand mean in the higher class with less than 50% of the credit that contributes to classification in the higher class.

## BORDERLINE ZONE FOR POSTGRADUATE AWARDS

Regulation 195:

- When considering borderline students, the PAB has the discretion to reclassify based on the individual student profile as presented on the marks array. Consideration may be given to the following:
  - Performance in the taught modules
  - Performance in the dissertation/project/ module

Regulation 196:

Exceptional circumstances do not provide grounds for reclassification of an award. In these
circumstances the PAB may consider offering a sit.

## NEW DECLARATION OF A DISABILITY [SCHOOL MEMO]

205. For postgraduate students, the Progression and Award Board will be advised of cases where support was offered after the start of the course so that a sit may be considered for modules with impacted marks prior to when the support was offered. No marks can be set aside.

## COMPENSATION

Reg 72 - 74

Automatically applied up to 30 credits where:

- Marginal fail 45-49%
- Uncapped stage mean of at least 50% (mean does not inc dissertation/ research project)
- Not given for a research project/dissertation module (unless ODL)

## CONDONEMENT

Regulation 78.

The PAB has discretionary authority to award up to a maximum of 30 condoned credits in the undergraduate or postgraduate final award stage where:

- the course learning outcomes have been met, and
- a fail mark on the module of at least 1 has been achieved, and
- the relevant uncapped stage mean of 50% for PGT courses.

## EXCEPTIONAL CIRCUMSTANCES

- Late penalty can be waived, or
- PAB has discretion to offer a maximum of 60 credits as second resits/sits of taught modules.
- PAB may decide not to offer a sit where it judged that the accepted exceptional circumstances had not negatively impacted on the module mark

## **RESITS AND SITS**

- A combined maximum of 60 credits of 2nd resits/sits may be offered (this does not include a first resit/sit or deferred dissertation).
- Candidates who had not passed 60 credits of taught modules at the July PAB were offered a choice of taking resits in A3 or repeating the stage to enable completion within the maximum period of registration.
- Candidates whose DIS/ PRO had been deferred to A1 may require resits/sits for other assessment components of the dissertation module.
- Where appropriate, a choice should be offered (e.g. TWD with second resits/ repeat S2 or an exit award).
- 2<sup>nd</sup> resits are at the discretion of the PAB for taught modules only.
