



# OVERVIEW

Colonial forms of power, knowledge and social ordering exist despite a broader move towards post-colonial societies. This module examines the historical and geographical context of colonialism and introduces de-colonial political projects and intellectual traditions. It will seek to examine a number of emancipatory political struggles for decolonised futures – including indigenous, feminist, environmental and black movements – from the past and present.

# TEACHING, LEARNING AND ASSESSMENT




- 1) a 1,500 word **CONCEPT NOTE** on 'decoloniality', due **MID-TERM (20%)**,

Teaching is by 3-hour workshops comprising short lecture presentations, group discussion and analytical/practical exercises.











Learning materials will include academic research and publications, social movement literature, photos, art, poetry, documentaries and videos.
