

Change of Study Location Application Form

(Postgraduate Researchers)

This form should be completed if you want to **temporarily** change your primary location for a period of time. i.e. to visit another education institution for a period more than one month (evidence of invitation required) or other study leave that supports your research but is not considered fieldwork. This form cannot be used to study remotely on a Student Route visa. There must be an academic reason specific to your degree to permit a change in location.

During this time the University will maintain sponsorship and you will continue to follow the University's Attendance, Absence and Engagement Policy.

All changes of study location must be approved by your main supervisor; therefore, travel should not be arranged until you have received written confirmation your change of study of location has been approved.

While away from the University of Sussex campus you are still required to fully engage with your research.

If you wish to **permanently** change your primary location. i.e. to return to your home country, or leave to the UK to live in another country and switching to a distance learning mode of attendance. Then you should complete the change of mode of registration form.

If you are on a Student visa this will involve the University withdrawing sponsorship of your visa, because remote study is not permitted on a Student visa. For further advice please contact the International Advisors or see further information on the Student Hub.
