

Research Degree Transfer Request (subject change)

A postgraduate researcher (PGR) may request a transfer to a different research degree at Sussex, where available, and provided that the transfer takes place before the giving notice of intention to submit and subject to the particular restrictions laid out in the <u>Policy on Research Degrees</u> (see section 7).

Before completing this application form please read the notes below carefully:

- 1. This form should be used where a PGR wishes to change subject registration, but remain at the same level of study (e.g. PhD). Changes between levels of study should be submitted using the *Application for Transfer of Registration from PhD to MPhil / MPhil to PhD* forms, available at the following link: <u>https://www.sussex.ac.uk/rsao/forms/</u>.
- 2. If you have a Student visa you **must** contact UKVI Compliance (<u>PGR-visas@sussex.ac.uk</u>) before completing this form. They will be able to advise on whether you need to make a new visa application before the transfer.

- 4. If you are in receipt of a scholarship from a source outside the University (e.g. a government scheme), you should contact the funder directly for advice on the implications of transferring research degree.
