

REGULATION 8: RESPONSIBILITY FOR CREATION AND AMENDMENT OF REGULATIONS

This Regulation may only be amended at a meeting of Council with the agreement of three-fourths present and voting, and having taken into account the views of Senate.

1. In accordance with Article 13 of the Charter, Council shall have the power to create, amend and revoke Regulations. Regulations may be created, amended and revoked at any meeting of Council.
2. The following table sets out the responsibility for the creation, amendment and revocation of each of the Regulations and the delegation of such power by Council to Senate in relation to specified Regulations.
3. Council also delegates the power to Senate to make further Regulations in addition to those set out below in relation to matters relating to the maintenance of academic standards.
