 - b. To what extent the analytical approach draws out findings that address/answer the key aims/objectives/research questions
 - c. To what extent the research paper considers and appropriately addresses the ethical treatment of participants
- 3. Give an overall evaluation of this research approach and its suitability for use in researching issues of occupational and organisational psychology.
- 4. Remember to include your Response to Feedback addendum if you are resubmitting a previously failed attempt at this assignment.
