News

Contribution to Knowledge & Understanding Guidance Released

REF released their latest guidance on the Contribution to Knowledge and Understanding (formerly Outputs) section of the REF2029 submission last month. Although REF2029 guidance will be formally finalised in 2026, and therefore this guidance module may be subject to small revisions, the guidance does provide useful clarity.

During REF2021 preparations, the RQI team maintained a UoA Leads Network which provided opportunities to discuss REF preparations and developments, such as REF guidance releases, and share best practices across the University. The RQI team will be setting up a UoA Leads Teams channel to provide an informal forum for these discussions as well as the opportunity to arrange regular or ad hoc meetings if the group feels these would be beneficial.

Elements Assessment Module REF Steering Group

Symplectic, the providers of Elements, are holding a REF Steering Group meeting in early September, where they plan to share their plans for REF2029 functionality in the Elements. Members of the RQI team and the Library's Research & Open Scholarship team will attend and any relevant information and updates will be shared via this newsletter.

After a successful re-launch this year, the regular meetings for the Sussex Impact Support Network have been postponed until the Autumn term to allow for as many participants as possible to attend. The next session will be on Knowledge Exchange and engaging with commercial partners. Details of the exact date and venue will follow.
