

WHO'S WHO:

1. SIDLEY & AUSTIN:

Chicago law firm representing G.D. Searle in Grand Jury investigation.

Sidley and Austin lawyers identified by Justice as representing Searle in Grand Jury investigation:

- Mr. John Robson

Also Mr. James Phelps from G.D. Searle was involved.

X 2. SAMUEL SKINNER:

U.S. Attorney when FDA first notified Justice of its interest in a Grand Jury investigation of G.D. Searle March 7, 1976. Received formal FDA request for Grand Jury January 10, 1977. "Recused" himself from the case March 8, 1977. Joined Sidley and Austin July, 1977.

X 3. WILLIAM F. CONLON:

Assistant U.S. Attorney assigned to Searle investigation in April, 1976, by Samuel Skinner. According to Justice, reduced or ended his involvement in Searle case on October 12, 1977. Joined Sidley and Austin on January 5, 1979, one month after closing of Searle investigation.

4. NEWTON MINOW:

Partner at Sidley and Austin. Though not listed by Justice as lawyer assigned to Searle case, attended meeting Sidley and Austin lawyers had with Skinner on Searle investigation on February 2, 1977. Minow later offered Skinner his job at Sidley and Austin.

5. FRED H. BRANDING: Assistant U.S. Attorney assigned to Searle investigation in April, 1976, by Samuel Skinner.
6. CHARLES KOCORAS: First Assistant U.S. Attorney in charge of Searle investigation from the time Skinner filed his "recusal" memo (March 8, 1977), to the time the new U.S. attorney, Thomas P. Sullivan, took charge (July, 1977).
7. THOMAS P. SULLIVAN: U.S. Attorney who closed Searle investigation, in December, 1978.
8. DANIEL E. REIDY: Assistant U.S. Attorney assigned to Searle case October 12, 1977.
9. ANTON VALUKAS: Left U.S. Attorney's office May 2, 1976, to join law firm of Jenner & Block. Current U.S. attorney for Northern Illinois.
10. CHARLES McCONACHIE: Acting Chief, Consumer Affairs Section, Antitrust Division U.S. Department of Justice, Washington, D.C.
11. RICHARD A. MERRILL: Chief Counsel, Food and Drug Administration.
12. ARTHUR N. LEVINE: Attorney, Food and Drug Administration. Assigned to Searle Investigation.
13. ADRIAN GROSS: Former FDA Toxicologist, member of 1975 FDA Searle Investigation Task Force.
